03/03/07 Spud @ 1:00 a.m. Drill 11" surface hole to 334'. Run 7 jts. of 8 5/8", 24 #, J55 ST & C casing at 319'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

03/04/07 Drill 7 7/8" hole from 334' - 2345'. Reached TD 2345' at 4:00 a.m. MIRU Superior and log well. Logger's TD at 2559'. Run 53 jts 5 1/2", 15.5 ppg, I-55, and 8 jts 17 ppg, I-55 LT&C casing at 2513'. HES mixed and pumped 380 sks Midcon II cement. Circulated 14 bbls of cement to surface.
