03/05/07 Spud @ 9:15 p.m. Drill 11" surface hole to 305'. Run 10 jts. of 8 5/8", 24 #, J55 ST & C casing at 305'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 8 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

03/06/07 Drill 7 7/8" hole from 305' - 2575'. Reached TD 2575' at 10:30 p.m. MIRU Superior and log well. Logger's TD at 2568'. Run 52 jts 5 1/2", 15.5 ppf, J-55, and 8 jts 17 ppf, J-55 LT&C casing at 2475'. HES mixed and pumped 298 sks Midcon II cement. Circulated 9 bbls of cement to surface.
