03/07/07 Spud @ 11:00 a.m. Drill 11" surface hole to 327'. Run 10 jts. of 8 5/8", 24 #, J55 ST & C casing at 317'. Halliburton mixed and pumped 100 sx Midcon II cement, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

03/08/07 Drill 7 7/8" hole from 327' - 2605'. Reached TD 2605' at 12:15 p.m. MIRU Superior and log well. Logger's TD at 2583'. Run 53 jts 5 1/2", 15.5 ppg, J-55, and 8 jts 17 ppg, J-55 LT&C casing at 2516'. HES mixed and pumped 273 sks Midcon II cement. Circulated 5 bbls of cement to surface.
