06/13/07 Drill 7 7/8" hole from 333' - 2415'. Reached TD at 2415' at 2:00 p.m. MIRU Superior and log well. Logger's TD 2401'. Run 51 jts 5 1/2", 15.5 ppf, J-55, and 10 jts 17 ppf, J-55 LT&C casing st 2333". HES mixed and pumped 377 sks Midcon II cement. Circulated 14 bbls of cement to surface.
