07/19/07 Drill 7 7/8" hole from 330' - 2215'. Reached TD at 2215' at 6:00 p.m. MIRU Superior and log well. Logger's TD 2200'. Run 46 jts 5 1/2, 15.5 ppf, J-55, and 8 jts 17 ppf, J-55 LT&C casing st 2144. HES mixed and pumped 284 sks Midcon II cement. Circulated 18 bbls of cement to surface.
