- 01/04/04 Spud @ 9:00 a.m. Drill 11" surface hole to 360'. Run 8 jts. of 8 5/8", J-55, 23 ppf ST&C casing to 352'. Halliburton mixed and pumped 15 bbls water, 100 sx Midcon II, 14 ppg, yield 1.66 at 4 bpm with 70 psi with 6 % salt, 5#/sx gilsonite, .3% versaset, .25 #/sk flocele. No cement to surface. Wait on cement 2.5 hours, topped off with 100 sx cement. No cement to surface. Wait on cement 1 hr. Pumped 8 bbls cement. Circulated 4 bbls of cement to surface. WOC 8 hrs. Test casing to 650 psi.
- 01/05/04 Drill 7 7/8" hole from 360' - 2215'. Reached TD 2215' at 11:00 a.m. MIRU Schlumberger & log well. Loggers TD at 2178'. Ran 44 jts. of 5 1/2", M-50, 15.5 ppf LT&C casing to 2144'. Halliburton mix and pump 25 bbls water, 40 bbls gel pre flush. Pumped 331 sx Midcon II PP, 13 ppg, yield 2.04 at 4 bpm. with 6 % salt, 2 lb/sx Granulite, 5 lb/sx Gilsonite, .3% Versaset, and .1% Super CBL. Bumped plug with 1200 psi. Float held. Circulated 38 bbls of cement to surface. Well shut in.
