01/25/04 Spud in @ 4:30 p.m. Drill 11" surface hole to 370'. Ran 8 jts of 8 5/8", J-55, 24 ppf ST&C casing to 363'. Halliburton mixed and pumped 100 sks Midcon II PP, 14 ppg, yield 1.66 at 3 bpm with 110 psi with 6% salt, .3% gilsonite, .3% versaset, and 25# flocele per sack. Circulated 4 bbls of cement to surface. WOC 8 hrs. Test surface casing to 500 psi for 30 min.

01/26/04 Drill 7 7/8" hole f/ 370' - 1345'. Reached TD at 1345'. MIRU Schlumberger & log well. Logger TD at 1296'. Ran 33 jts of 5 1/2", 17#, J-55 LT &C casing to 1275'. Halliburton mixed and pump 40 bbls gel pre flush at 4 bpm at 25 psi, 161 sks Midcon II, 13.0 ppg, yield 2.04, .3% versaset, 5#/sx gilsonite, 2#/sk granulite, 6% salt and .1% Super CBL. Plug bumped w/ 1200 psi. Circulated 19 bbls of cement to surface. Well shut in.
