XTO Energy Inc. respectfully requests approval to modify the existing downhole commingle order DHC 3232~~A~~, approved 1/20/04, by the addition of the Wildcat Basin Mancos formation to the existing DHC order. Presently DHC 3232~~A~~ pertains to the downhole commingling of the Otero Chacra, Blanco Mesaverde and the Basin Dakota pools in the Florance #72. Upon approval of the modification to downhole commingle, the well will be completed and the pools commingled. The WI, NRI and ORRI ownership are common between all pools.
