Extension of Administrative Order SWD-293

Dear Mr. Schwab:

As per your request on behalf of Sagle & Schwab Energy Resources ("S&S") received in this office April 19, 2004, and for the reasons outlined in your letter, a one-year extension of the deadline in which to resume injection in the Pot Mesa Well No. 2 (API No. 30-031-20888), approved by Division Order No. SWD-293, is hereby granted with the following conditions.

Just prior to resuming injection, the operator shall submit the following data to the Division in Santa Fe.

- Casing and cement top data on all wells drilled to at least the top perforation depth and within ½ mile radius of this injection well.
- All wells and pools producing and/or considered prospective within a 2-mile 2) radius of this injection well.
- Plot of available injection data vs time, including daily injection rate and wellhead pressure.
 - Current static fluid level and estimated reservoir pressure.
- Statement verifying that a pressure limiting device is installed and operational at 5) or near the wellhead.

The injection authority for this well shall expire on July 1, 2005, if the operator has not resumed injection.

Dear Mr. Jones:

To confirm your discussion with Marcia Stewart, SG Interests (c/o Sagle & Schwab Energy Resources, PO Box 2677, Durango, CO 81301) became the operator of the captioned well effective July 1, 2003 (former operator, Merrion Oil & Gas, 610 Reilly Ave., Farmington, NM 87401-2634). Although Merrion was injecting water during the month of June, 2003, SG elected to shut the well in (on July 1, 2003) until a later date. It is SG's intent to recomplete and evaluate gas/oil wells in the area before making a determination concerning this water disposal well. If SG finds a need for this well, injection equipment will be upgraded prior to any injection operation.

Bruce Martin of NMOCD in Aztec, NM informed us that after a year of no injection, we would lose our authority to inject. Consequently, we are requesting a one (1) year extension for the Pot Mesa #2 injection well.

Please let me know if you need any additional information. Thank you for your help.
