Dear Mr. Stogner:

Cross Timbers Operating Company hereby requests administrative approval for an unorthodox location for the captioned well. Attached for your reference are the following exhibits:

1. Well Location Plat (NMOCD Form C-102);
2. Ownership Map; and
3. List of Offset Owners.

The captioned well is a replacement well for the Cross Timbers Fogelson #1 well (API # 30-045-09122) which is currently shut-in and we plan to plug this well. The current rules state that the proposed replacement well be located no closer than 790' to any outer boundary of the quarter section on which the well is located and not closer than 130' to any quarter-quarter section line or subdivision inner boundary. The proposed location will not conform to the current footage requirements.

The area (approx. 5 acres) around the proposed location for the captioned well has been subjected to extensive run off. The soil makes a transition from a grassy sand loam to a loose clay-based soil with little vegetation and numerous Pinion and Juniper trees. At this time, this area of transition is not able to maintain water control and large amounts of topsoil are being lost downhill.

As this well is to be located on a federal lease, a BLM on-site inspection was conducted on June 21, 2000, with a BLM representative, Mr. Danny Randell. At that time, Mr. Randell indicated that our choice for a standard location (790' FEL & 1,850' FSL) would remove too many of the existing trees and that it would accelerate the topsoil loss currently being experienced in the area. He preferred that the well be moved uphill to the sandy loam area (660' FEL & 1,980' FSL). The BLM has suggested that during the construction of the well pad, the existing washes can be improved to protect our location and result in better water control around the clay-based area. Also, water from the hill above the drill pad will have a better chance of being diverted into the two improved washes located on the east and west side of the lower clay area.

In summary, Cross Timbers and the BLM feel that if our location is approved the entire area would benefit from better water control and thereby reduce the amount of topsoil being lost downhill.

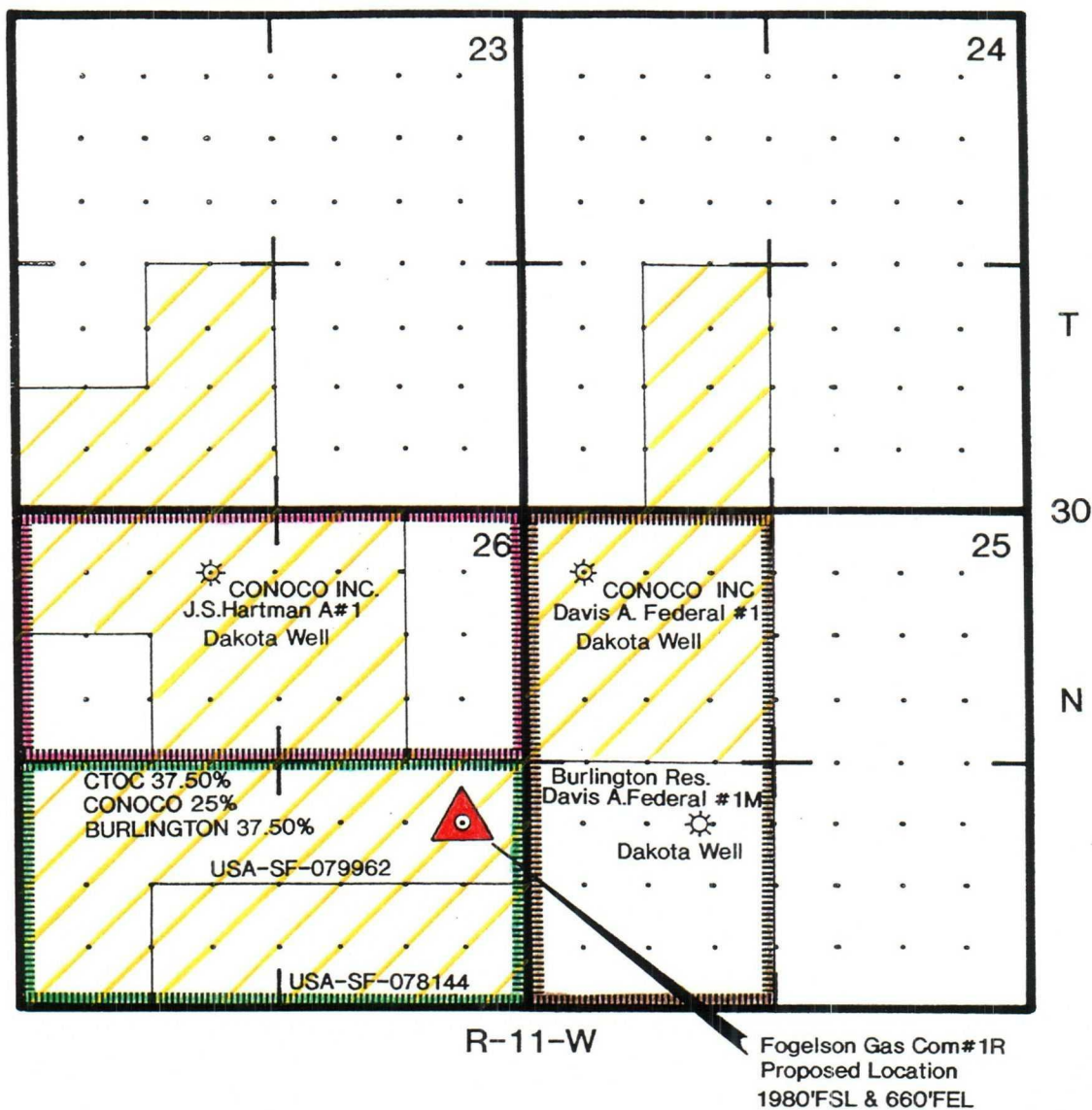
