Marathon Oil Company respectfully requests an exception to Rule 104 for a 40 acre non-standard spacing for the Lou Worthan No. 15 in the Tubb Oil and Gas (86400) Gas pool. This gas pro-ration unit will be comprised of the area in Unit Letter "G", Section 11, T-22-S, R-37-E in Lea County, New Mexico.

Currently, the remaining 120 acres of this quarter are dedicated to three wells in forty acre increments leaving UL "G" as the only undeveloped Tubb acreage in the 160 acre pro-ration unit. These wells consist of two oil wells and one gas unit on a non-standard pro-ration unit. The other Tubb Oil & Gas wells are as follows:


There are two other wells in this quarter section that are producing from reservoirs other than the Tubb Oil & Gas. These are as follows:


