These wells are located on various State of New Mexico, Navajo Tribal, U.S. Bureau of Land Management, and fee leases. All production shall be continuously metered on lease prior to commingling with other leases. Compressor fuel gas usage shall be allocated to each lease and well according to measured lease and well production rates.

REMARKS: The commingled natural gas production shall be delivered to the PNM Navajo CDP gas sales meter located on the Eaton White Well No. 1 location in the SE/4 NW/4 of

Section 20, Township 29 North, Range 13 West, NMPM, San Juan County, New Mexico. Above an agreed upon pressure, the gas shall be diverted, measured, and sold through the El Paso Bluffs CDP located in the NE/4 NE/4 of Section 29, Township 29 North, Range 13 West, NMPM, San Juan County, New Mexico.

This order shall be amended if additional gas is to be processed through this gas gathering system from additional pools in these areas or from additional wells in offsetting areas. Amendments in the future shall not require formal notification to original interest owners in the gathering system as approved by this order, but will require formal notification to all interest owners in the additional wells to be added and in the additional pools to be completed. If changes to this system in the future result in changes to the agreed upon methods of production allocation, notice of these changes shall be provided to all interest owners.

FURTHER: The operator shall notify the Aztec District Office of the Division upon implementation of commingling operations.
