

Application for Unorthodox Location
Gallegos Canyon Unit Well No. 562
W/2 Section 22-T29N-R12W
Basin Fruitland Coal Pool
San Juan County, New Mexico

Amoco Production Company respectfully requests an administrative approval for an unorthodox location for the Gallegos Canyon Unit Well No. 562 to be drilled at a location of 2030' FNL and 2440' FEL of Section 22, T29N-R12W. The unorthodox location is necessitated by extreme topographical conditions and would insure the conservation of surface and subsurface resources in the area. A designated Superfund Site (known as Lee Akers) encompasses a significant portion of the Southwest Quarter. In the SW/4 of the section are numerous building structures, as is indicated on topographical APD Map # 1. The subject well is currently staked at a location 400' from the outer boundary of the Superfund Site. A representative of the Bureau of Land Management (Surface Owner) was on site during the staking of this well and gave initial approval to the drilling location.

To aid in your review attached is a C-102 Well Location Plat showing the well location, a topographical map (APD Map # 1), a 9 section plat showing the offset wells and operators and map obtained from the BLM outlining the Superfund Site.

Richardson Operating Company is the only affected offset operator and is being furnished a copy of this application by certified mail return receipt requested.


No New Road Construction
