Dear Mr. Stogner:

Energen Resources Corporation (Energen) previously requested Administrative Approval for an Unorthodox Location of its proposed Turner Hughes # 8S Fruitland Coal well under the provisions of New Mexico Oil Conservation Division (NMOCD) Order R-8768. This request was returned denied due to a lack of information relating to the ownership of the offsetting section.

The well is located 910' FNL & 2225' FWL of Section 4-T27N-R9W, San Juan County, New Mexico and is located on BLM lease SF-078050. It is dedicated to a 330.98 acre gas spacing unit consisting of Lots 7-10, 15-18 (W/2) of said Section 4, in the Basin Fruitland Coal gas pool. Energen owns 100% of the working interest in this spacing unit.

This well is closer than 660 feet to the eastern boundary of the proration unit, causing a non-standard location. This well is being proposed on this well pad due to rough topography and to avoid an archeological site.

Energen is the operator of the E/2 Section 4, an offsetting spacing unit and none of the other offsetting spacing units. Energen owns 100% working interest in this spacing unit through the same oil and gas lease that covers the W/2 of Section 4. A copy of this application is therefore being sent to the remaining offsetting spacing unit operators by certified mail-return receipt request with a request that they furnish your office a Waiver of Objection within 20 days of receipt of this application. Attached is a well location plat showing dedicated acreage (C-102), a map showing all offsetting operators and a topographic map.

This application is being returned with the additional information added. Your favorable consideration of this request would be appreciated. Please advise should you require additional information in this regard.
