Under the provisions of NMOCC Order R-5359 we are requesting administrative approval for downhole commingling of Fruitland and Pictured Cliffs production on the well listed below for the following reasons:

Operator	Well Name and Number	Location
Jerome P. McHugh	Nasaea #6	J-36-27N-12W

1. The bottom-hole pressure is estimated to be


375 psig for the Fruitland formation, and  
325 psig for the Pictured Cliffs formation.

2. Both zones will be marginal producers with

250 MCFGPD estimated for the Fruitland formation, and 71%  
100 MCFGPD estimated for the Pictured Cliffs formation. 29%

We believe the granting of this request will permit the production of marginal reserves from both formations and not result in waste.

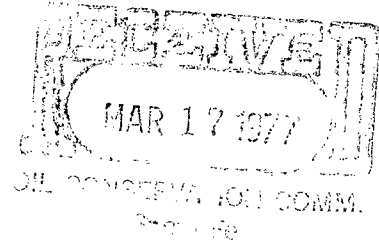

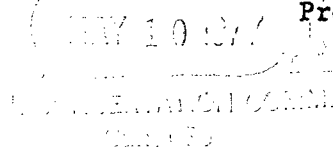
