

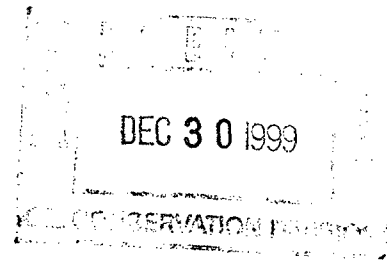

**RE: REQUEST FOR ADMINISTRATIVE APPROVAL OF UNORTHODOX WELL LOCATION
SAN JUAN 29-5 UNIT #60M WELL
NW/4 SECTION 32-29N-5W
RIO ARriba COUNTY, NEW MEXICO
PHILLIPS CONTRACT C40452**

Ladies and Gentlemen::

Phillips Petroleum Company (Phillips) as Operator of the captioned well, respectfully requests administrative approval of an unorthodox well location for the said well.

Phillips proposes to drill the San Juan 29-5 Unit #60M well at a location of 880' FNL & 325' FWL of Section 32-29N-5W, Rio Arriba County, New Mexico. This well will be a commingled well located in the Basin Dakota and Blanco Mesaverde Pools and will have the W/2 of Section 32 designated as the drillblock for the Mesaverde and the N/2 of Section 32 designated the drillblock for the Dakota. This is an orthodox location for the Mesverde, (as per Order No. R-10987-A) and is an infill well for the Mesaverde Pool, however, it is not an orthodox location for the Dakota Pool as currently established.

Extensive archeological considerations and to some degree, topographical concerns at an orthodox location require that this location be utilized. It is unlikely that a separate Dakota well could be drilled as a stand-alone well on an economic basis. The economics are improved through the investment savings realized by drilling the well as a Dakota/Mesaverde commingled well. The most viable alternative to recover Dakota reserves is to drill the Mesaverde infill wells as commingled wells, thus necessitating our request. Additionally, this creates less surface disturbance, which is an increasing concern of the BLM and Fee surface owners.

For your benefit in reviewing this request, we are providing the following:



This drill block is located within the confines of the San Juan 29-5 Unit. 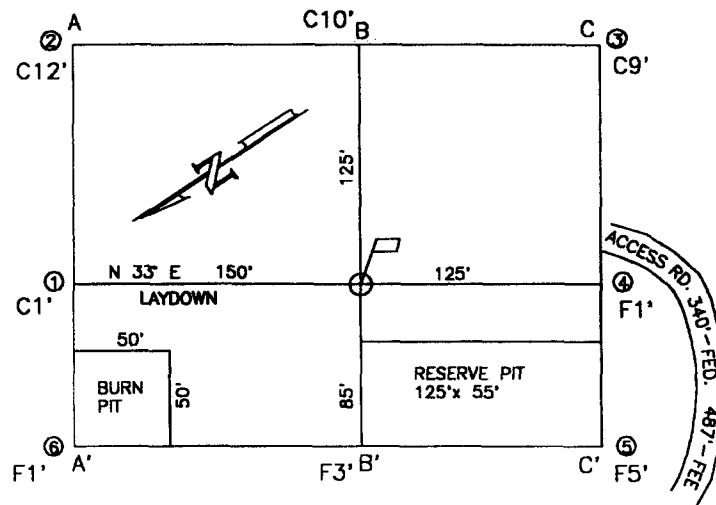

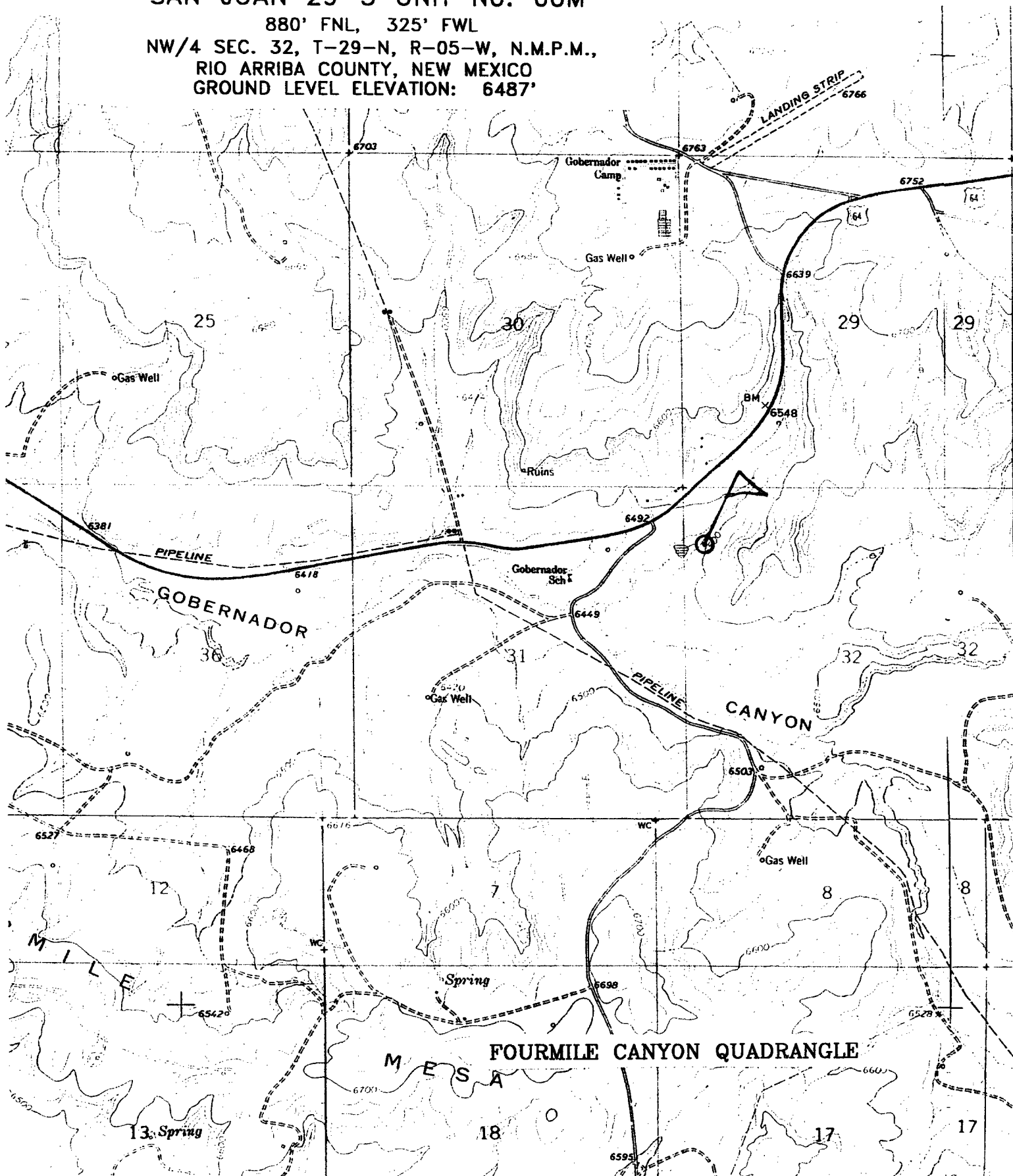

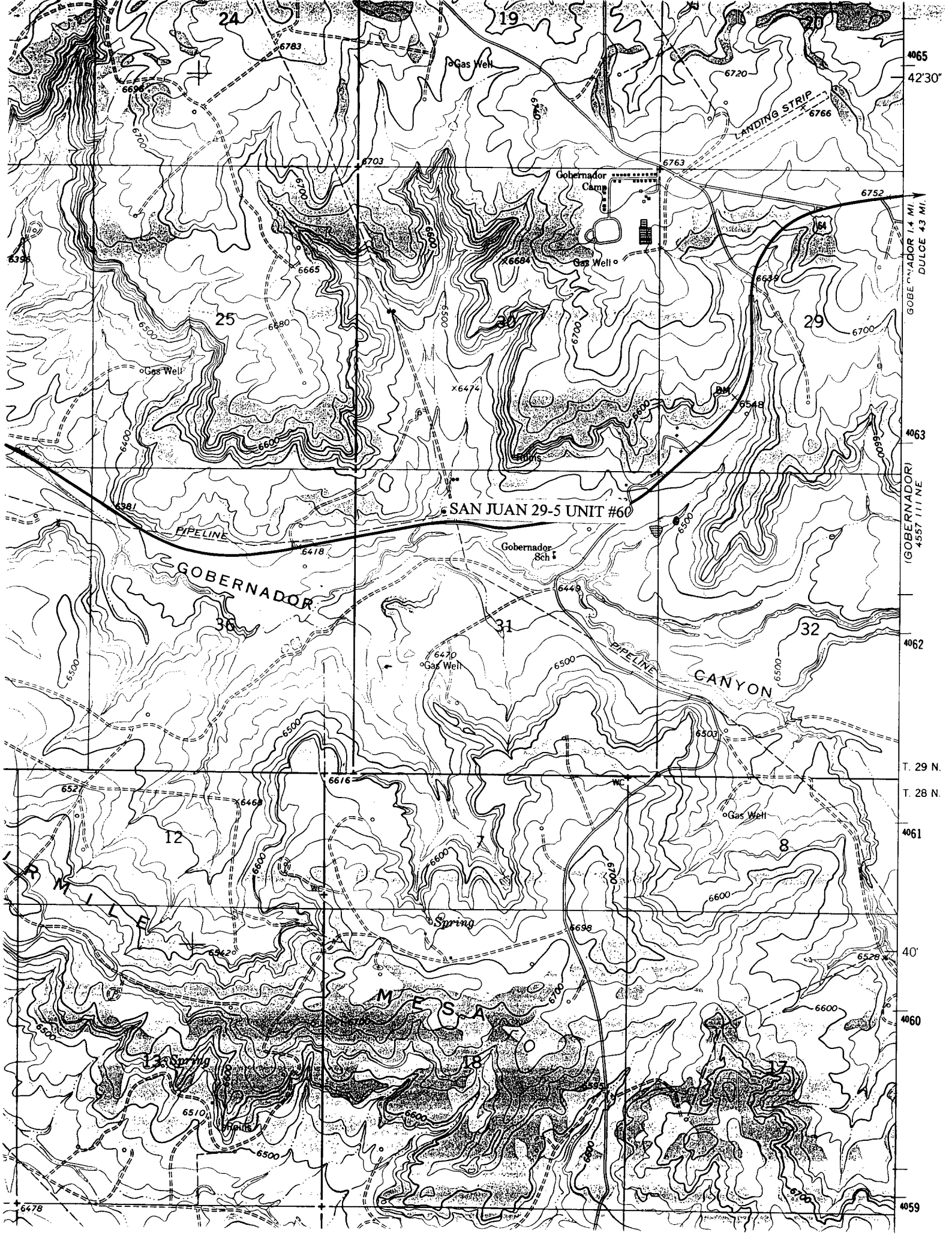
