Dear Mr. Brand:

Reference is made to your letter of October 23, 1992, wherein you have requested our approval to permit the production from the subject well to be commingled from the Drinkard, Blinebry and Paddock pools in the wellbore.

We have derived the following information from your application:

- 1. The produced fluids should be compatible and commingling these fluids should not result in precipitates which might damage the reservoir. Both zones will produce sour oil and gas. The three zones are currently surface commingled and have not caused problems in the battery.
- 2. The value of the commingled stream will not be diminished from the value of separate stream sales.
- 3. The zones to be commingled have common ownership.

Since it appears that there will be no loss of revenue to the State of New Mexico as a result of your proposed operation, your request for downhole commingling is hereby approved. Any deviation from the substance of your request will be sufficient grounds for rescinding our approval. Our approval is subject to like approval by the New Mexico Oil Conservation Division.
