Your application to downhole commingle the production from within the wellbore of the above-captioned well was received on February 14, 2005. Your application requests our approval to downhole commingle the Comanche (Wolfcamp) and Comanche Spring (Pre-Permian) production within the wellbore of the Stingray State Unit Well No. 1 located in the NW/4NE/4 of Section 18-10S-27E, Lea County, New Mexico.
