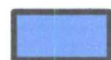

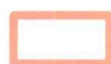

Enclosed please find a copy of the application filed by Apache Corporation ("Apache") with the New Mexico Oil Conservation Division for authorization to simultaneously dedicate an existing 40-acre non-standard gas spacing and proration unit in the Blinebry Oil & Gas Pool (Prorated Gas-72480) comprising the SW/4 NE/4 of Section 14, Township 20 South, Range 38 East, NMPM, Lea County, New Mexico, to the existing Apache Roitan Well No. 1 (API No. 30-025-34735) located at a standard gas well location 1650 feet from the North and East lines (Unit G) of Section 14, and to the proposed Roitan Well No. 1 (API No. 30-025-40018) to be drilled at a standard gas well location 2310 feet from the North and East lines (Unit G) of Section 14.

Special rules for the Binebry Oil & Gas Pool require formal application and Division approval to dedicate more than one gas well to a non-standard 40-acre gas spacing and proration unit. Apache has determined that the existing Roitan No. 1 will drain approximately 12 acres of the 40-acre spacing unit. Consequently, Apache believes that an additional well is necessary in order to recover the remaining oil and gas reserves in the Blinebry Oil & Gas Pool underlying this tract.

As the owner of an interest that may be affected by the proposed simultaneous dedication, you are being provided notice as per Division rules and regulations. Objections must be filed in writing at the Division's Santa Fe office within 20 days from the date this notice was sent to you. If no objection is received within twenty days after the filing of this application and proof of notice with the Division, the application may be approved.
