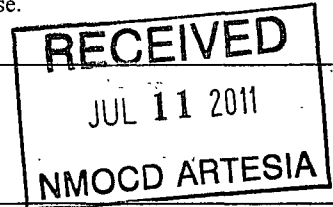

Ran into pattern south & west; water pooled up in low spot approx 125 ft south. area (110x80) water soaked. Ran water in small drain, 2x4 ft wide approx 150 ft. All available water vacuumed up. (will file Work Plan for remediation)
