Initially 20bbls of oil was released from the circulating pump inside the dike walls of the lined Miranda Federal Tank Battery. Due to rainwater, we were able to recover a total of 25bbls of fluid. All free fluids were recovered. Contaminated gravel has been removed from the lined facility. Clean gravel has been added as necessary. The facility has been returned to its prior condition. (The closest well location to the tank battery is the Miranda Federal #2, API # 30-015-37332, Unit G. Sec-9-T17S-R30E, 2130' FNL 2260' FEL, 32.850510 - 103.975853.)
