Thompson Engineering and Production Corp. (TEPC) requests administrative approval to complete a Wildcat Fruitland Sand in the existing Glade Park #1 well bore in a non-standard location. The Glade Park #1 is located within the city limits of Farmington, NM. The Glade Park #1 was drilled in the only location in the quarter section that met the City of Farmington set-back requirements and was acceptable to adjacent surface owners. If the Fruitland Sand completion is successful, the plan is to down hole commingle the production with the existing Fruitland Coal production. The DHC request will be a separate application.

TEPC owns the mineral rights in the SW/4 of Section 9 which is the direction that this well encroaches upon. XTO owns the other offsetting proration units and has been notified of this application by certified mail.




Well Location Map


