Pursuant to Division Rule 19.15.15.13, Legend Natural Gas III, LP respectfully requests administrative approval of a non-standard location (NSL) for the State GQ 5H in Eddy County, New Mexico. This application is being sent in regards to the State GQ 5H production interval being 20' from the Quarter/Quarter line in Section 7 of Township 25S and Range 28E in the Hay Hollow; Bone Spring, North pool (30216).

The affected offset wells to the State GQ 5H are the State GQ Com 3H and the State GQ 4H. All three wells are operated by Legend Natural Gas III, LP, and all three are in the same lease and have common interest and surface owners.

Attached is Form C-102 showing the project area of the proposed well, as well as the two existing wells. Also, attached, showing in color, the half section that is operated by Legend and the placement of the three wells within that half section.

Approval of this application will allow Legend Natural Gas to recover additional oil and gas reserves from the Hay Hollow; Bone Spring, North pool underlying the East half of Section 7 that may otherwise not be recovered by the existing and proposed wells, thereby preventing waste, and will not violate correlative rights.

Good morning Ms. Mosley

If the beginning of the completed interval of the proposed well is at least 330 feet from the north line of Section 7, then you are correct that notice to owners in Unit O of Section 6 is not required. I did not see any statement to that effect in your application when I read it yesterday.

The way the well path is sketched on the attached C-102, however, raises an additional notice issue. Under our interpretation of our setback rules as applied to diagonal offsetting spacing units, if any part of the "completed interval" is less than 467 feet from the common corner of Unit B of Section 7 and Unit P of Section 6, then notice to affected persons in Unit P of Section 6 is required. This is because the location would be closer to the common corner than the closest standard location (330 feet from N and 1650 from E).

In addition to the foregoing, the well path as you have drawn it on the attached C-102 raises another issue. If the lateral will actually be 1320 from the East line, it would be exactly on the quarter-quarter line. Although it is difficult to believe it could be drilled that precisely, my understanding of OCD interpretation would be that a spacing unit is not "penetrated" by a lateral that is exactly on its outer boundary. Thus, a W/2 E/2 project area could not be designated for the proposed well so located. This difficulty would be obviated if the location of the lateral were moved 10 feet to the west.



Respectfully, I am still confused.

If the point identified on the new plat that appears to be on the line between units A and B is the beginning of the completed interval, the notice issue is resolved, because that point is indicated to be 530 FNL and therefore greater than either the straight or the diagonal offset distances from both Units O and P of Section 6.

However, if the beginning of the completed interval is 1325 FEL, as the plat seems to suggest, that would put that point in Unit B of Section 7, and would accordingly require that Unit B be included in the project area.
