Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval for two unorthodox oil well locations for its proposed Bertha J. Barber Wells No. 15 and 16, as described above. These wells will be drilled as development oil wells in the Eunice Monument Grayburg-San Andres Pool (23000) at the unorthodox well locations described above in Unit A of Section 7, Township 20 South, Range 37 East, NMPM, Lea County, New Mexico.

The proposed Bertha J. Barber Wells No. 15 and 16 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Eunice Monument Grayburg-San Andres Pool comprising the NE/4 NE/4 of Section 7. This unit is currently dedicated to Apache's Bertha J. Barber No. 2 (API No. 30-025-05974) located at a standard well location 330' FNL & 990' FEL, which is currently temporarily abandoned. In addition, Apache has filed APD's for the following wells: i) Bertha J. Barber Well No. 17 (API No. 30-025-41283) which may be drilled at a later time at an unorthodox location 1310 feet from the North line and 140 feet from the East line; and ii) Bertha J. Barber Well No. 18 (API No. 30-025-41267) which also may be drilled at a later time at an later time at a standard location 820 feet from the North line and 475 feet from the East

line. Both of these wells, if drilled, will also be dedicated to the NE/4 NE/4 of Section 7 in the Eunice Monument Grayburg-San Andres Pool.

The Eunice Monument Grayburg-San Andres Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The NE/4 NE/4 of Section 7 is a part of the Bertha J. Barber Lease, which comprises the E/2 E/2 of Section 7, and the NW/4 NW/4 & NW/4 SW/4 of Section 8. This fee lease is owned 87.875% (WI) by LeaCo New Mexico Exploration & Production, LLC, which is an Apache entity, and 12.125% (WI) by Poco Partners, Ltd. The two offset 40-acre tracts that are affected by the unorthodox locations are the NW/4 NW/4 of Section 8, which is affected by the Bertha J. Barber No. 15, and the SE/4 NE/4 of Section 7, which is affected by the Bertha J. Barber No. 16. The affected NW/4 NW/4 of Section 8 is currently operated in the Eunice Monument Grayburg-San Andres Pool by Apache. The affected SE/4 NE/4 of Section 7 is currently not developed in the Eunice Monument Grayburg-San Andres Pool. Pursuant to Division rules, Apache is providing notice of this application, by certified mail return receipt, to Poco Partners, Ltd., the only working interest owner affected by these unorthodox well locations.

The attached map shows the current and proposed well development pattern within the NE/4 NE/4 of Section 7, and the NW/4 NW/4 of Section 8. The proposed unorthodox locations are necessary: i) in order to efficiently and effectively drain and develop the Bertha J. Barber Lease; and ii) to complete an efficient and effective 40-acre five spot injection pattern at such time in the future as this lease may be subject to a pilot of full-scale secondary recovery operations in the Grayburg-San Andres interval.

Attached are Form C-102's for each well showing the proposed well, well locations and dedicated acreage. Also attached is a map that shows the current and proposed well development pattern within the NE/4 NE/4 of Section 7 and the NW/4 NW/4 of Section 8. Also shown on this map is the affected offset acreage.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Eunice Monument Grayburg-San Andres Pool underlying the NE/4 NE/4 of Section 7 that may otherwise not be recovered by the existing or proposed producing wells, thereby preventing waste, and will not violate correlative rights.


