Pursuant to NMAC 19.15.15.13, Mewbourne Oil Company applies for approval of an unorthodox oil well location for the following well:

<u>Well:</u>	Winchester 36 HE State Well No. 1H
<u>Surface location:</u>	2370 feet FNL & 150 feet FEL
<u>Landing Point:</u>	2335 feet FNL & 622 feet FEL
<u>Bottom hole location:</u>	1900 feet FNL & 330 feet FWL
<u>Well unit (project area):</u>	S½N½ of Section 36, Township 19 South, Range 28 East, N.M.P.M., Eddy County, New Mexico


The well will be drilled to a depth sufficient to test the Bone Spring formation (Winchester-Bone Spring Pool). The pool is spaced on 40 acres, with wells to be located no closer than 330 feet to a quarter-quarter section line. A Form C-102 is attached as Exhibit A.

A portion of the producing interval of the wellbore will be unorthodox. The unorthodox location will increase the productive length of the wellbore. In addition, the surface location was chosen to place the wellsite near an existing lease road.

Attached as Exhibit B is a land plat. The only potentially affected persons are in the N/2S/2 of Section 36. All of Section 36 is covered by State Lease E-5073, which has common ownership in the Bone Spring formation. Therefore, the offsets are unaffected and notice of the application has not been sent to any offset.






