The commingled oil and gas production from the wells detailed above shall be measured and sold at the State A Central Tank Battery (CTB), located in Unit letter "K" Section 16, Township 17 South, Range 31 East, and State B (CTB) located in Unit letter "J" Section 16, Township 17 South, Range 31 East, NMPM, Eddy County, New Mexico. This amendment also authorizes the inclusion of State A (CTB) which was not included in the original order.

The oil and gas production from each well shall be continuously measured with allocation meters before commingling with production from other wells. The allocation meters shall be calibrated quarterly.

This installation shall be installed and operated in accordance with the applicable Division Rules. It is the responsibility of the producer to notify the transporter of this commingling authority.

The proposed (CTB) is in the best interests of conservation and waste from the affected wells. Correlative rights will not be impaired, and will not result in reduced royalty or improper measurement of production

The operator shall notify the Artesia District office of the Division prior to implementation of the commingling operations.

This approval is subject to like approval from the State Land Office before commencing commingling operations.
