Dear Ms. Bailey:

EOG Resources, Inc. (OGRID No. 7377) seeks administrative approval of an unorthodox well location for its **Dragon 36 State 6H Well** to be completed within the Red Hills; Upper Bone Spring Shale Pool (Pool Code 97900) underlying Section 36, Township 24 South, Range 33 East, N.M.P.M., Lea County, New Mexico. This well will be drilled from a surface location 220 feet from the South line and 1965 feet from the East line of Section 36. The upper most perforation will be located 330 feet from the South line and 1385 feet from the East line of Section 36 (Unit O) and the lower most perforation will be 330 feet from the North line and 1385 feet from the East line of Section 36 (Unit B). Since this acreage is governed by the Division's statewide rules which provides for wells to be located no closer than 330 feet to the outer boundary of the spacing unit, the completed interval for this well will be unorthodox because it is closer than 330 feet to the eastern boundary of the project area. Approval of the unorthodox completed interval will prevent waste of a productive portion of the reservoir and improve well performance.

Exhibit A is the Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Dragon 36 State 6H Well** encroaches on the spacing and proration units to the Southeast, East and Northeast.

Exhibit B is a land plat for Section 36 and the surrounding sections that shows the proposed **Dragon 36 State 6H Well** in relation to adjoining units and existing wells.

Exhibit C is a list of the parties affected by the encroachment to the Southeast and the Northeast. Each of these parties have been provided notice of this application by certified mail. EOG is the sole operator and mineral lessee of the state lease covering Section 36. Accordingly, there are no

affected parties by the encroachment to the East. Nonetheless, a copy of this application has been provided to the New Mexico State Land Office.






