Pursuant to 19.15.36.8(E) NMAC, the Oil Conservation Division (OCD) has reviewed your Surface Waste Management Facility application, dated April 19, 2013 and received by OCD on April 22, 2013, and has found it to be administratively complete. Given the administrative completeness determination, you may now proceed to the notice as specified in 19.15.36.9(A) NMAC. As the applicant, you are required to furnish proof to OCD that required notices have been given. Please provide this proof to OCD as soon as possible. Proof of notice may begin the 30 day public comment period.

OCD will also provide notice of its administrative completeness determination within 30 days from the date of this letter per 19.15.36.9(B) NMAC. The public has 30 days to comment from the date of notice provided by the applicant or the date that OCD distributes notice, whichever is later. (See 19.15.36.9(C) NMAC)

The determination of administrative completeness does not mean that the application meets the technical requirements of 19.15.36 NMAC. OCD will now evaluate the technical merits of your application. Within 60 days after the end of the public comment period, OCD will issue its tentative decision regarding your application. (See 19.15.36.9(D) NMAC)

Mr. Kirk,

R360 Permian Basin, LLC, (R360) a subsidiary company of R360 Environmental Solutions LLC, (head quartered at Greenspoint Plaza 4, 16945 Northchase Drive, Houston, Texas, 77060) has submitted an application to the New Mexico Oil Conservation Division (Division) to obtain a permit to construct and operate a surface waste management facility, under New Mexico Authoritative Code (NMAC) 19.15.36, on property leased by R360 Environmental Solutions.

The Division requires that you, as an adjoining surface owner, be notified of this permit application.

The facility will be located on approximately 36 acres in Section 36, Township 26 South, Range 31 East, based on the New Mexico Meridian in Eddy County, New Mexico. There is not a physical address established for the property, but the facility will be located on the south side of Stateline Road, approximately 0.41 miles west of the intersection of State Line Road and County Road 1.

Division regulations require a 50 foot separation from the design base of the facility and the shallowest protectable ground water bearing zone. R360 has confirmed that groundwater was absent down to 70 feet below the ground's surface at this location. Records available for a well approximately 150 feet south of the Texas/New Mexico state line indicates that the water level at this location occurs at approximately 245 beneath the Proposed Facility. The total dissolved solids concentration of the well is unknown; however a wind mill well to the east had a total dissolved solids concentration of 589 milligrams per liter.

The facility will operate as a waste transfer facility for Resource Conservation and Recovery Act (RCRA) exempt wastes. The Application describes a waste transfer facility that will conduct the following waste management activities:

1. Offloading, storage and transfer of off-site waste in enclosed containers for off-site disposal at an approved facility;
2. Removal of free liquids from enclosed containers, and the aggregation, storage and transfer of those liquids for off-site disposal at an approved facility;
3. Removal, storage and transfer of any spill residues for off-site disposal at an approved facility; and
4. Removal, storage and transfer of contact storm water for off-site disposal at an approved facility.
