

Pursuant to Division Rule 19.15.15.13, Legend Natural Gas III, LP respectfully requests administrative approval of a non-standard location (NSL) for the Browning Federal Com 6H in Eddy County, New Mexico. This application is being sent in regards to the Browning Federal Com 6H proposed production interval being 71.7' at the first take point and 22.9' at the last take point from the West quarter/quarter line in Section 17, T-24-S, R-28-E in the Willow Lake; Bone Spring, North pool (64450).

The affected offset wells to the Browning Federal Com 6H are the Browning Federal Com 3H and the Browning Federal Com 4H, all proposed APD's with the Bureau of Land Management. Notification has been send via certified mail to the offset mineral owners as well as working interest owners. Copies of the certified mail receipts are attached. We are also requesting a Non-Standard Spacing unit as we are requesting to dedicate 320 acres to the Browning Federal Com 6H.
