Pursuant to your application received on May 5, 2014, DEVON ENERGY PRODUCTION COMPANY, LP (OGRID 6137) is hereby authorized to surface commingle oil and gas production from the following pools located in Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico;

Ingle Wells; Delaware	(33745)
Livingston Ridge; Delaware, South	(96149)

and from the following diversely owned wells identified in attachment A, and made part of this order. These wells are located on federal leases in said Township and Range in Eddy County, New Mexico:

The commingled oil and gas production for the Barclay wells shall be measured and sold at the Barclay 11 "G" Federal Well No. 7 Central Tank Battery (CTB), located in Unit G, Section 11, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico.

The commingled oil and gas production for the Todd wells shall be measured and sold at the Todd 14 "K" Federal Well No. 1 Central Tank Battery (CTB), located in Unit K, Section 14, Township 23 South, Range 31 East, NMPM, Eddy County, New Mexico.

Oil and gas production from each of the leases shall be separately metered before commingling with production from other wells. The allocation meters shall be calibrated quarterly in accordance with Rule 19.15.12.10.C (2) NMAC.

The operator shall notify the transporter of this commingling authority.

The operator shall notify the Artesia district office of the Division upon commencement of commingling operations.
