The commingled oil production shall be measured and sold at the Poker Lake Unit Well No.261 Central Tank Battery (CTB) located in Unit J, Section 21, Township 24 South, Range 30 East, Eddy County, New Mexico.

Oil production from the wells shall be measured and allocated back to each well using periodic monthly well tests.

The operator shall notify the transporter of this commingling authority.


The operator shall notify the Artesia district office of the Division upon commencement of commingling operations.


