Re: Application of WPX Energy Production, LLC for administrative approval of a 80-acre non-standard spacing unit in the Basin Mancos Gas Pool; approval of two unorthodox well locations in the spacing unit; and approval of downhole commingling of the Nageezi Gallup Pool (Pool Code 47540) and the Basin Mancos Gas Pool (Pool Code 97232), San Juan County, New Mexico.

Dear Mr. Catanach:

WPX Energy Production, LLC (OGRID 120782) owns a leasehold interest in the S/2 S/2 of Section 5, Township 23 North, Range 8 West, N.M.P.M., San Juan County, New Mexico. WPX plans to drill the **Chaco 2308-08A 285H Well** and the **Chaco 2308-04L 459H Well** as horizontal wells in the S/2 S/2 of Section 5. The **Chaco 2308-08A 285H Well** will be drilled from a surface location of 328 feet from the North line, 334 feet from the East line (Unit A) of Section 8. The completed interval will commence no closer than 380 feet from the South line, 380 feet from the East line (Unit P) and the final perforation will be 380 feet from the South line, 331 feet from the West line (Unit M) of Section 5. The **Chaco 2308-04L 459H Well** will be drilled from a surface location at 2431 feet from the South line, 427 feet from the West line (Unit L) in Section 4. The completed interval will begin at approximately 1274 feet from the South line, 380 feet from the East line (Unit P), and the last perforation will be no closer than 1274 from the South line, 331 feet from the West line (Unit M) of Section 5.

The SE/4 of said Section 5 is located in the Basin-Mancos Gas Pool (97232) and subject to the special rules for that pool created under Order R-12984. The SW/4 of said Section 5 is located in the Nageezi-Gallup Pool (47540), an oil pool that is not listed in paragraphs (3) and (4) of Order R-12984. The Nageezi Gallup Pool (47540) is subject to 40-acre spacing and 330 foot setbacks per Statewide Rule 19.15.15.9 NMAC.

The special rules for the Basin-Mancos Gas Pool require that an oil well drilled within the area encompassed by these rules that is near an oil pool not listed in paragraphs (3) and (4) of Order R-12984 must conform to the special rules for the Basin-Mancos Gas Pool. See Appendix

A to Order R-12984 (special rules) at Rule 1. These special rules require 320-acre spacing and that the well remains 660 feet from the outer boundary of the spacing unit. *Id.* at Rule 2.

The completed interval of the **Chaco 2308-08A 285H Well** located in the Nageezi-Gallup Pool in the S/2 SW/4 of Section 5 will be at a standard location. However, the remaining portion of the wellbore located in the Basin-Mancos Gas Pool in the S/2 SE/4 of Section 5 will have dedicated to it a non-standard 80 -acre spacing unit comprised of Units P and O instead of the 320-acre spacing unit required by the special pool rules. In addition, the portion of the wellbore in the S/2 SE/4 will be at a non-standard location 380 feet from the outer boundary of the proposed unit instead of 660 feet required by the special rules.

The completed interval of the **2308-04L 459H Well** located in the Nageezi-Gallup Pool in the S/2 SW/4 of Section 5 will be at a standard location. However, the remaining portion of the wellbore located in the Basin-Mancos Gas Pool in the S/2 SE/4 of Section 5 will have dedicated to it a non-standard 80-acre spacing unit comprised of Units P and O instead of the 320-acre spacing unit required by the special pool rules. In addition, the portion of the wellbore in the S/2 SE/4 will be at a non-standard location 380 feet from the outer boundary of the proposed unit instead of 660 feet required by the special rules.

To efficiently develop this acreage under these circumstances, WPX requires approval of the following:

- (1) Pursuant to NMAC 19.15.15.11(B)(2), approval of a non-standard 80-acre spacing and proration unit in the Basin Mancos Gas Pool, comprised of the S/2 SE/4 of Section 5;
- (2) Pursuant to NMAC 19.15.15.13(C), approval of two unorthodox locations in the Basin Mancos Gas Pool;
- (3) Pursuant to NMAC 19.15.12.11.C(1), approval of the commingling of production from the Nageezi-Gallup Pool and the Basin-Mancos Gas Pool for each of WPX's two proposed horizontal wells to be located in the S/2 S/2 of said Section 5.

Exhibit 1 is a land plat of Section 5 and the surrounding sections showing the location of the **Chaco 2308-08A 285H Well** and the **Chaco 2308-04L 459H Well** in the S/2 S/2 of Section 5 and the adjoining spacing units and wells.

Exhibit 2a and 2b are Well Location and Acreage Dedication Plats (Form C-102s) showing that as a result of the 660 foot setbacks required by the special rules for the Basin Mancos Gas Pool, the proposed completed intervals for the **Chaco 2308-08A 285H Well** and the **Chaco 2308-04L 459H Well** encroach on the spacing and proration units to the North, Northeast, Southeast, and South.

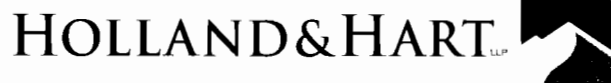


Exhibit 3 is a copy of a completed form C-107-A (application for downhole commingling).
