Matador Production Company (OGRID No. 228937) seeks administrative approval of an unorthodox well location for its B Banker 33-23S-28E RB #221H well (API No. 30-015-43306) to be completed within the Culebra Bluff, Wolfcamp, South (Gas) pool (Pool Code 75750) underlying the N/2 of Section 33, Township 23S, Range 28E, N.M.P.M., Eddy County, New Mexico. Attached as **Exhibit A** is C-102 for the well. This is a horizontal well that will be drilled as follows:

B Banker 33-23S-28E RB #221H

- Surface Hole Location: 771 feet from the North line and 384 feet from the East line of Section 33, Township 23 South, Range 28 East;
- First Perforation Point: 330 feet from the North line and 330 feet from the East line of Section 33;
- Last Perforation Point: 330 feet from the North line and 330 feet from the West line of Section 33; and
- Bottom Hole Location: 330 feet from the North line and 240 feet from the West line of Section 33.

Matador Production Company is requesting this NSL in order to efficiently produce its interests in Section 33. This well is producing from the Culebra Bluff, Wolfcamp, South (Gas) pool (Pool Code 75750). There are no

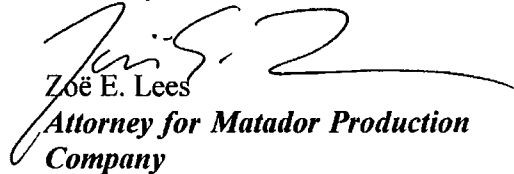

special pool rules for this pool, and thus the setback requirements under Rule 19.15.15.10(B) of 660' apply. As a result, the completed interval for this well is closer than 660' from the boundary of the project area. The unorthodox location will encroach towards the S/2 and NW/4 of Section 27, Section 28, the S/2, and NE/4 of Section 29, the N/2 and SE/4 of Section 32 and the N/2 and SW/4 of Section 34. **Exhibit B** is list showing the surrounding ownership and the project area for the proposed B Banker 33-23S-28E RB #221H well in relation to adjoining units.

Exhibit C is a list of the parties affected by the encroachment. Each of these parties have been provided notice of this application by certified mail, return receipt requested, advising them that if they have any objection to this well, it must be filed with the New Mexico Oil Conservation Division within 20 days of the mailing of this notice. In addition, a copy of this application has also been provided to the New Mexico State Land Office.
