Reference is made to your request on behalf of BTA Oil Producers, LLC (OGRID 260297; "BTA") received by the Division on September 27, 2016, for the above named well. BTA has requested the cancellation of Administrative Order SWD-1571-A approved on May 25, 2016.

It is our understanding that BTA has requested cancellation of the order after negotiation with Mesquite SWD, Inc. for the opportunity to become the potential operator of this well for commercial disposal of produced water. The Division finds that granting this request is in the interest of conservation and will prevent waste and protect the environment. Therefore, the authority issued to BTA under Administrative Order SWD-1575-A is cancelled.
