Pursuant to Rule 3 of the Special Rules for the Purple Sage-Wolfcamp Gas Pool and NMAC 19.15.15.11.B(2), BTA Oil Producers, LLC ("BTA") (OGRID No. 260297) seeks administrative approval of a 160-acre non-standard spacing and proration unit comprised of the NE/4 of Section 32, Township 23 South, Range 28 East, NMPM, Eddy County, New Mexico. The proposed non-standard spacing and proration unit will be combined with a standard 320-acre spacing unit in the E/2 of Section 29 to form a 480-acre project area dedicated to the Ogden 20509 29-32 Fed Com No. 1H Well and the Ogden 20509 29-32 Fed Com No. 2H Well.

These wells will develop the Wolfcamp formation (Purple Sage; Wolfcamp Gas Pool (98220)). Specifically, the Ogden 20509 29-32 Fed Com No. 1H Well will target the Wolfcamp D interval, the Ogden 20509 29-32 Fed Com No. 2H Well will target the Wolfcamp sand interval. Pursuant to the Special Rules for the Purple Sage-Wolfcamp Gas Pool, set forth in Order No. R-14262, wells within the Purple Sage Pool must be spaced on 320-acres. Rule 3 of the Special Rules for Order R-14262 permit exceptions as allowed in Division rules. The Division rule 19.15.15.11.B(2) authorizes administrative approval of non-standard spacing units when the non-standard spacing unit consists of a single quarter-quarter section or lot or quarter-quarter sections or lots joined by a common side and the non-standard spacing unit lies wholly within a single half section if the well is in a pool for which 320 acres is the standard spacing unit size. The proposed non-standard spacing unit consists of a djoining units and is located wholly within a single half-section.

BTA seeks approval of this non-standard spacing unit to most efficiently develop the Wolfcamp in this area. BTA is the 100% working interest owner in the NE/4 of Section 32. All

other interest owners within the proposed 480-acre project area, including the proposed nonstandard spacing unit, have previously been made aware of BTA's development plan.

The possible tracts that could be combined with the NE/4 of Section 32 to form a standard spacing unit are the NW/4 or the SE/4 of Section 32. The SE/4 of Section 32 is already included in a standard spacing unit in the Purple Sage-Wolfcamp Gas Pool, encompassing the S/2 of Section 32, which unit is being developed by Mewbourne Oil Company's Zeppelin 32 W2LI State Com No. 2H Well (spud January 18, 2018) and Zeppelin 32 W0LI State Com No. 1H Well (currently permitted). Accordingly, there are no affected parties in the SE/4 of Section 32 (Tract 1).

Exhibit A is a copy of the Well Location and Acreage Dedication Plats (Form C-102) for the two proposed wells.

Exhibit B is a land plat showing the proposed wells and the proposed spacing unit in the NE/4 of Section 32 and the E/2 of Section 29. As described above, BTA is the 100% working interest owner in the NE/4 of Section 32 and there are no affected parties in the SE/4 of Section 32. Accordingly, the only affected parties are in the NW/4 of Section 32 (Tract 1).

Exhibit C is a list of the working interest owners, royalty owners, and overriding royalty owners in the NW/4 of Section 32 (Tract 1). 
