Marathon Oil Permian LLC ("Marathon"), OGRID Number 372098, is seeking administrative approval of an unorthodox well location ("NSL") for the **Achilles 8 WA FC 3H well** (the "Well") to be completed within the Purple Sage; Wolfcamp (Gas) (Pool Code 98220) underlying the E/2 of Section 5, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- <u>Surface Hole Location</u>: 905' from the South Line and 1190' from the East Line of Section 5, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico;
- First Take Point: 100' from the South Line and 996' from the East line of Section 5;
- <u>Last Take Point and Bottom Hole Location</u>: 100' from the North Line and 1016' from the East line of Section 5, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico.

Marathon has included as Exhibit B a letter explaining why this application is needed. This well will produce from the Purple Sage; Wolfcamp (Gas) (Pool Code 98220). 





