Devon Energy Production, LP ("Devon") (OGRID No. 6137) seeks administrative approval of an unorthodox well location for its **Mr Potato Head 11-14 Fed Com 622H Well** (API No. 30-025-pending) to be completed within the Purple Sage Wolfcamp Pool (98220) underlying the W/2 of Sections 11 and 14, Township 24 South, Range 29 East, N.M.P.M., Eddy County, New Mexico. This well will be drilled from a surface location 350 feet from the north line and 1,135 feet from the west line (Unit D) of Section 11 to a bottom hole location 20 feet from the south line and 1,870 feet from the west line (Unit N) of Section 14. The upper most perforation will be located 120 feet from the north line and 1,870 feet from the south line and 1,870 feet from the north line and 1,870 feet from the south line and 1,870 feet from the north line and 1,870 feet from the west line (Unit N) of Section 14.

Pursuant to Division Order R-14262, this acreage is governed by the Special Rules for the Purple Sage-Wolfcamp Gas Pool which provide for wells in the Wolfcamp formation in Eddy County to be located no closer than 330 feet to the outer boundary of the spacing unit. The completed interval for the **Mr Potato Head 11-14 Fed Com 622H Well** will be unorthodox because it is closer than 330 feet to the northern and southern boundaries of the project area. Approval of the unorthodox completed interval will allow Devon to use its preferred well spacing plan for horizontal wells in this area and thereby prevent waste.

**Exhibit A** is a Well Location and Acreage Dedication Plat (Form C-102), which shows that the completed interval of the proposed **Mr Potato Head 11-14 Fed Com 622H Well** encroaches on the drilling and spacing units to the north and south.

**Exhibit D** is a statement from a Devon's petroleum engineer confirming that Devon's requested unorthodox location is necessary to optimize well spacing, thereby preventing waste.





It is Devon's responsibility as a prudent operator to maximize lateral length and to minimize reserves left in the ground. Decreasing the first and last take point will increase the wells effective lateral length by 460 feet thereby increasing ultimate recovery of reserves and thereby preventing waste of natural resources.
