Thanks for talking earlier. After discussion with NMOCD, and in addition to the issues we talked about, there are some issues regarding the closure sampling. NMAC19.15.29D(1)c states that closure samples cannot contain an area larger than 200 square feet with division approval. As such NMSLO and NMOCD have agreed to accept closure if 2 additional confirmation samples are taken; 1 between SP2 & SP3 and another between SP3 and SP4. These samples can be taken for chlorides only, TPH, BTEX and Benzene are not necessary. This should be enough to satisfy the remediation

requirements of the spill rule. Reclamation of the pasture will be able to occur next. Please get in touch if you have any questions or issues.
