I left a message on your voice mail, but am reaching out via email as well to make sure you are aware of the requirements we are looking at for the CTB application for the Morrison SAU 942H. The time we are required to allow for protest is 20 days which would have started on October 30th. However, one of the royalty owners looks like they could not be found which requires a notification be published in the local newspaper. The 20 days can not start until the publication date.

In addition, it looks like you are including a number of leases in your application, but currently only have 2 wells. Are you asking for the additional leases to be added to this order for future drilling? Or am I mistaken about the request for the additional leases to be added?
