Re: Amended Application of Solaris Water Midstream, LLC to permit for salt water disposal in the proposed Breckenridge State SWD #1 Well to be located in Section 32, Township 24 South, Range 35 East, NMPM, Lea County, New Mexico

Dear Ms. Sandoval:

The original application stated that the surface location of the Breckenridge State SWD #1 well would be 2595' FSL and 1545' FWL in the section/township/range shown above. The application was amended on 12/19/2018, to move the well to 300' FSL and 500' FEL in the same section/township/range. The purpose of this letter is to amend the application for a third and final time. The surface location of the Breckenridge State SWD #1 well will be 300' FSL and 200' FEL in Section 32, Township 24 South, Range 35 East, NMPM, Lea County, New Mexico. There are no other changes to the application.

Enclosed is an amended form C-102 showing the correct footage calls for the surface location along with the correct plats and maps showing the revised and final location. This amendment is being made to satisfy concerns by COG Operating, LLC. Their concerns have all been addressed and COG Operating, LLC has waived objections to this well as shown in their letter to Solaris, dated February 25, 2019 which is attached.

This change in location will not affect any other part of the application. The new AOR does not include any wells that were not addressed in the original application. Further, no additional adjacent operators were identified after the move, so no additional notifications are required. All other attachments to the original C-108 have not changed. The surface owner remains the same as in the original application, however, Solaris is copying them on this letter so that they are aware of the new location.

Re: Breckenridge State SWD Well No. 1 Letter Agreement Section 32, T24S-R35E, Lea County, New Mexico ("Section 32")

Mr. Carpenter:

Reference is made to the application of Solaris Water Midstream, LLC ("<u>Solaris</u>"), dated August 8, 2018, wherein Solaris seeks approval of Oil Conservation Division Form C-108 (Application for Authorization to Inject; the "<u>Application</u>") for the Breckenridge State SWD No. 1 (the "<u>Well</u>") to inject produced water for disposal purposes into the Devonian-Silurian formation. In consideration for the terms set forth herein, COG Operating LLC ("<u>COG</u>") agrees to waive objection to the Application on the following conditions:

- 1. At its sole cost, risk and expense, Solaris will run a wireline continuous gyro throughout the wellbore of the Well, and Solaris agrees, free of charge, to give COG access to all such data in order to reduce the risk of wellbore collision that may be present with COG's current and future development.
- 2. Solaris will, free of charge, provide COG with all data collected in the wellbore of the Well no later than thirty (30) days after Solaris collects or has access to such data.

Solaris's operations in connection with its drilling, casing, cementing, equipping or operating the Well will not restrict or impede COG's access to its well heads or surface facilities, or in any way interrupt or impair COG's access to or exploration, development or production operations on its leasehold.

Notwithstanding anything to the contrary herein, if Solaris amends the Application, COG shall have the right to revoke this waiver of objection to the Application.

If you agree with the foregoing terms and provisions of this agreement, kindly signify your approval in the space provided below for your signature and return to Mike Wallace at the letterhead address. This agreement shall be null and void for all purposes and of no further force and effect unless countersigned by Solaris and returned to COG on or before March 11, 2019.


