

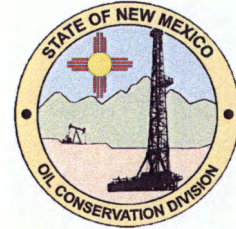

OFF-LEASE MEASUREMENT

Administrative Order OLM-185

Marathon Oil Permian, LLC

Pursuant to your application received on January 2, 2020, Marathon Oil Permian, LLC ("Operator") is hereby authorized to transport and measure oil and gas production off-lease from the wells and associated leases identified in Exhibit A and incorporated by reference into this Order. The wells are located in Section 36, Township 22 South, Range 26 East, NMPM, Eddy County, New Mexico.

The commingled oil production from the wells shall be measured either by a lease automatic custody transfer ("LACT") meter or by a run ticket mutually agreed upon by Operator and the oil transporter. The measurement and sell of the commingled oil production shall occur at the respective central tank battery ("CTB") described in Exhibit A.

The gas production from the wells shall be measured by a custody transfer meter and sold at the respective CTB described in Exhibit A.

All meters for the wells shall be physically separated from facilities for other wells, so that production from the wells will not be commingled prior to measurement with production from any other well.

This permit does not authorize the surface commingling of this oil and gas production with production from other pools or leases.
