**Re: Application of Marathon Oil Permian LLC for administrative approval of unorthodox well location for Willow Lake 15 WXY Fee 7H well located in Section 15, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico.**

Dear Director Sandoval:

Marathon Oil Permian LLC (“Marathon”), OGRID Number 372098, is seeking administrative approval of an unorthodox well location (“NSL”) for the **Willow Lake 15 WXY Fee 7H well** (the “Well”) to be completed within the Purple Sage Wolfcamp Gas Pool (Pool ID: 98220) underlying the S/2 S/2 of Section 15, Township 24 South, Range 28 East, NMPM, Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Hole Location: 1342’ from the South line and 296’ from the East line of Section 15;
- First Take Point: 330’ from the South line and 100’ from the East line of Section 15;
- Last Take Point and Bottom Hole Location: 330’ from the South line and 100’ from the West line of Section 15.

Marathon has included as Exhibit B a letter explaining why this application is needed. Marathon also provides a midland map of this area, attached as Exhibit C.

This well will produce from the Purple Sage Wolfcamp Gas Pool (Pool ID: 98220). The special pool rules establish 330’ foot setback requirements. The completed interval for the proposed well is closer than 330’ from the boundary of the spacing unit. The unorthodox location will encroach towards the SE/4 of Section 16 and the SW/4 of Section 14 of Township 24 South, Range 28 East.

Pursuant to NMAC 19.15.4.12(A)(2) and NMAC 19.15.2.7(A)(8), when, as here, the adjacent tracts are dedicated to existing spacing units, notice must only be provided to the operator of those spacing units. Mewbourne Oil Company (Mewbourne) is the operator of a 480-acre Wolfcamp spacing unit in the NE/4 of Section 21 and the E/2 of Section 16, Township 16, Township 24 South, Range 28 East (*see* Case No. 16234; Order No. R-20295) (the Creedence unit), which is the unit covering the section directly adjacent to the west of the proposed Willow Lake 15 WXY Fee 7H well. Matador Production Company (Matador) is the operator of a 320-acre Wolfcamp spacing unit located in the S/2 of Section 14, Township 24 South, Range 28 East (the Tiger unit), which is the unit covering the section directly adjacent to the east of the proposed Willow Lake 15 WXY Fee 7H well. Marathon is providing notice to both Mewbourne and Matador. Proof of mailing, along with a copy of the notice letter sent to affected parties, is attached hereto as Exhibit D.

Marathon Oil Permian LLC respectfully requests administrative approval of the non-standard location for the Willow Lake 15 WXY Fee 7H well, to be drilled in the Purple Sage; Wolfcamp (Gas) pool (98220). Marathon plans for this well to have a first take point at 330' FSL and 100' FEL of Section 15, 24S-28E, and a last take point at 330' FSL and 100' FWL of Section 15, 24S-28E which is closer to the unit line than allowed under the subject field rules. Marathon requests this non-standard location because the placement conforms to the first and last take points of the other wells in the section, this spacing best fits into the spacing of wells in the plan of development for the entire section and we believe that it will result in the greatest recovery of reserves.




