Dear Mr. Lowe:

Chevron U.S.A. Inc., by and through its counsel, hereby protests the above-referenced administration applications for Nonstandard Locations for the wells listed above and more fully described in such applications filed by Oxy USA Inc. on January 6, 2020.

Chevron owns a working interest in the adjacent sections upon which the proposed last take point for these wells will encroach and is therefore an "affected person" under Rule 19.15.15.13(D) and was provided notice of the applications.

Chevron requests that the applications be set for hearing in accordance with NMAC 19.15.15.13(E) and denied after hearing for the following reasons:

- Chevron has producing Purple Sage wells to the north of the Oxbow wells' last take points. Chevron's wells were permitted and drilled per standard field rules. Chevron believes that allowing Oxy to perf closer to the lease line will cause drainage of Chevron's minerals and impair its correlative rights.
- The current field and spacing rules are appropriate to develop this area, and nothing about these particular sections merits the need for a non-standard location.

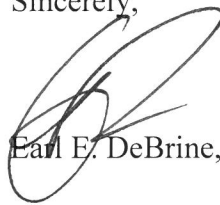
