EOG Resources, Inc. ("EOG") (OGRID No. 7377) seeks to amend the administrative approval granted in NSL-7972, authorizing an unorthodox well location for its **Neptune 10 State Com #102H Well** (API No. 30-025-44464) to be completed within the Triplex; Bone Spring Pool (59900) underlying the W/2 E/2 of Section 3 and 10, Township 24 South, Range 33 East, N.M.P.M., Lea County, New Mexico.

NSL-7972 authorized EOG to drill its well at the following location:

EOG has changed its drilling plans for the **Neptune 10 State Com #102H Well** and now intends to drill this well from a surface location 130 feet from the south line and 2202 feet from the east line (Unit O) of Section 10. The bottom hole, and first and last take points remain unchanged. A revised Form C-102 for this well is attached as **Exhibit 1**.

Accordingly, EOG requests the Division amend NSL-7972 to reflect the above-described changes to the surface hole location for the **Neptune 10 State Com #102H Well**. These changes do not require updated notice to any of the affected parties because the encroachments on the offsetting spacing units are unchanged.
