RE: Application for administrative approval to authorize lease commingling, off-lease storage, and off-lease measurement at the Chaco 23 08 03 well pad facility located in SE/NE, Section 3, Township 23 North, Range 8 West, N.M.P.M., San Juan County, New Mexico

LOGOS Operating, LLC (LOGOS) (OGRID 289408) seeks approval to surface commingle production from various federal leases from the Basin Mancos Pool (97232); and off-lease storage and measurement.

- (a) The **323.2 acres** underlying Lots 1, 2, 3, 4 and S2/N2 of Section 3. Dedicated to the currently producing Chaco 23 08 03 1H (API 30-045-35647), Chaco 23 08 03 2H (API 30-045-35646), and the proposed Chaco 23 08 03 3H (API 30-045-38171).
- (b) The **323.44 acres** underlying Lots 1, 2, 3, 4 and S2/N2 of Section 2, and from the **80.28 acres** underlying Lot 4 and SW/NW of Section 1. Dedicated to the proposed Zeus 2308 03 4H (API 30-045-38179) and Omega 2308 03 5H (API 30-045-38180).

The surface commingle production from the separate leases will be at a common surface facility located in Section 3 on federal surface. The common surface facility is off-lease for the production from leases NM120374 and NM109397 for the proposed Zeus 2308 03 4H and Omega 2308 03 5H. Oil, gas and water production from each of the geographic areas will be separately metered using an orifice meter for gas, Coriolis meter for oil, and a turbine meter for water at this facility.

From the individual wells, each flows to a unique production separator, at the separator outlet each well shall be separately metered before commingling with production from other wells. Gas is measured by orifice meter, oil is measured by Coriolis meter, and water is measured by turbine meter. Gas used in gas lift operation is also metered uniquely for each well by orifice meter. The gas used in gas lift operation (reinjecting for artificial lift) for each well is netted against the separator measured gas to calculate a net gas volume for each well.

Gas used on the site for production equipment (heaters, generators, engines) is measured by orifice meter and allocated to each well based on the net gas production allocation.

Gas recovered by the vapor recovery unit is measured by orifice meter, combined with the site gas stream and allocated to each well based on the oil production allocation, per the Coriolis meters.

After measurement by the individual well allocation meters and gas lift meters, the net gas for each well will be commingled prior to delivery to the gas pipeline gatherer where the gas is measured by the gatherer orifice delivery meters. Any gas returned for use on the site is measured by a gatherer return gas orifice meters. The gas delivered to the gatherer minus any gas returned by the gatherer will be allocated based on the gas allocation meter percentages.

After measurement by the individual well allocation meter, the oil will be commingled and stored in sealed tanks, tank levels are recorded by radar measurement. When tank volume is sufficient for delivery to the oil pipeline gatherer the oil is measured by the gatherer LACT meter. FIFO method per allocations.

The meters shall be calibrated in accordance with 19.15.12.10.C (2) NMAC, BLM 43 CFR 3174 and 3175 requirements.

LOGOS, anticipates the Chaco 23 08 03 #3H, Zeus 2308 03 #4H and Omega 2308 03 #5H will produce oil and gas in paying quantities, based upon ample evidence provided by wells in close proximity. Based upon public data, the average EUR for all producing horizontal Gallup oil wells is ~50 BO/ft. to date.

Currently, the Chaco 23 08 03 #1H and the Chaco 23 08 03 #2H have EURs exceeding 80 BO/ft. and remain producing oil and gas in paying quantities. The Chaco 23 08 03 #3H will be an infill to the Chaco 23 08 03 #1H and Chaco 23 08 03 #2H. LOGOS has experienced success infilling two Gallup oil horizontal locations within 3 miles of the anticipated Chaco 2308 03 #3H at similar spacing intervals. Accordingly, LOGOS anticipates the Chaco 23 08 03 #3H will perform similar to other infill Gallup wells in the area and will produce oil and gas in paying quantities.

The existing wells in 23N 8W Sections 1 and 2, which lie directly south of the spacing unit for the Zeus 2308 03 #4H and Omega 2308 03 #5H have an average EUR exceeding 80 BO/ft. Accordingly, LOGOS is very optimistic that the Zeus 2308 03 #4H and Omega 2308 03 #5H will have similar outcomes and will produce oil and gas in paying quantities.
