Re: Amended Application of Solaris Water Midstream, LLC to permit for salt water disposal in the proposed Steel Dust Fed SWD #1 well to be located in Section 32, Township 23 South, Range 27 East, NMPM, Eddy County, New Mexico

Dear Ms. Sandoval:

The original application, dated 7/26/2018, stated that the surface location of the Steel Dust Fed SWD #1 well would be 202 FNL and 346' FWL in Section 32, Township 23 South, Range 27 East, NMPM, Eddy County, New Mexico. The amended location will be 407.7' FNL and 1,360.4' FWL, in Section 32, Township 23 South, Range 27 East, NMPM, Eddy County, New Mexico. There are no other changes to the original application.

Enclosed is an amended form C-102 showing the correct footage calls for the surface location along with the correct plats and maps showing the revised location. This amendment is being made to satisfy concerns of the Bureau of Land Management. During the BLM on-site inspection of the proposed location, the BLM expressed concerns of a biological and/or archeological nature and decided that the surface location should be moved. Their concerns have been addressed and the amended surface location referred to above is the result.

This change in location will not affect any other part of the application. The new AOR does not include any wells that were not addressed originally. Further, no additional adjacent operators were identified after the move, so no additional notifications are required. All other attachments to the original C-108 have not changed. The surface owner remains the same, however, Solaris is copying them on this letter so that they are aware of the new location.








STEEL DUST SWD 1




STEEL DUST SWD 1








STEEL DUST SWD 1



