Marathon Oil Permian LLC (“Marathon”), OGRID Number 372098, is seeking administrative approval of an unorthodox well location (“NSL”) for the **Trojan Horse 35 WB Fed Com 1H well**, (the “Well”) to be completed within the Purple Sage; Wolfcamp (Gas) Pool (Pool Code 98220) underlying the W/2 of Section 35, Township 22 South, Range 28 East, and W/2 of Section 2, Township 23 South, Range 28 East, N.M.P.M., Eddy County, New Mexico. N.M.P.M., Eddy County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- First Take Point: 100’ from the North line and 330’ from the West line of Section 35, Township 22 South, Range 28 East;
- Last Take Point: 100’ from the South line and 330’ from the West line of Section 2, Township 23 South, Range 28 East.

Marathon has included as Exhibit B a letter explaining why this application is needed. This well will produce from the Purple Sage Wolfcamp Pool (Pool Code 98220). There are special pool rules for this pool under Order No. R-14262, that establish 330’ foot setback requirements. The completed interval for the proposed well is closer than 330’ from the boundary of the spacing unit.

Marathon is also providing notice to the Bureau of Land Management as the owner of the mineral estate with respect to offsetting areas. 
Marathon Oil Permian LLC respectfully requests administrative approval of the non-standard location for the Trojan Horse 35 WB Fed Com 1H well, to be drilled in Purple Sage; Wolfcamp (Gas) pool (98220). Marathon plans for this well to have a first take point at 100' FNL and 330' FWL of Section 35, and last take point at 100' FSL and 330' FWL of Section 2, which is closer to the unit line than allowed under the subject field rules. Marathon requests this non-standard location because the placement conforms to the first and last take points of the other wells in the section. This spacing best fits into the spacing for the other wells in the development plan of the entire section and we believe that it will result in the greatest recovery of reserves.


