Franklin Mountain Energy, LLC ("FME"), OGRID Number 373910, is seeking administrative approval of an unorthodox well location ("NSL") for the **Ouray Fed Com 703H well** (the "Well") to be completed within the WC-025 G-09 S253502D Upper Wolfcamp Pool (98187) underlying the W/2 of Sections 4 and 9, Township 24 South, Range 35 East, NMPM, Lea County, New Mexico. A C-102 for the Well is attached as Exhibit A. This is a horizontal well that will be drilled as follows:

- Surface Hole Location: 325' from the South line and 1325' from the West line of Section 9;
- First Take Point: 858' from the South line and 2316' from the West line of Section 9;
- Last Take Point: 150' from the North line and 2426' from the West line of Section 4.
- Bottom Hole Location: 150' from the North line and 2426' from the West line of Section 4.

FME has included as Exhibit B a letter explaining why this application is needed. This well will produce from the WC-025 G-09 S253502D Upper Wolfcamp Pool (98187). This pool follows statewide pool rules, which establish 100' setbacks for first and last take points and 330' setbacks for completed laterals. The completed lateral for the proposed well is closer than 330' from the boundary of the spacing unit.

The unorthodox location will encroach towards the (1) SE/4 SW/4 of Section 33, Township 23 South, Range 35 East and 2) the NE/4 NW/4 of

Section 16, Township 24 South, Range 35 East and 3) the N/W4 NE/4 of Section 16, Township 24 South, Range 35 East. FME is providing notice to the working interest owners in the SE/4 SW/4 of Section 33, Township 23 South, Range 35 East and the working interest owners in the N/2 of Section 16, Township 24 South, Range 35 East (ownership is uniform across the N/2). FME is also providing notice to the Bureau of Land Management and the State Land Office as owners of mineral estates with respect to offsetting areas. FME also provides a midland map of this area, attached as Exhibit C, and an annotated midland map showing the horizontal spacing unit and the affected tract. Proof of mailing notice and the application to affected persons entitled to notice is attached hereto as Exhibit D.

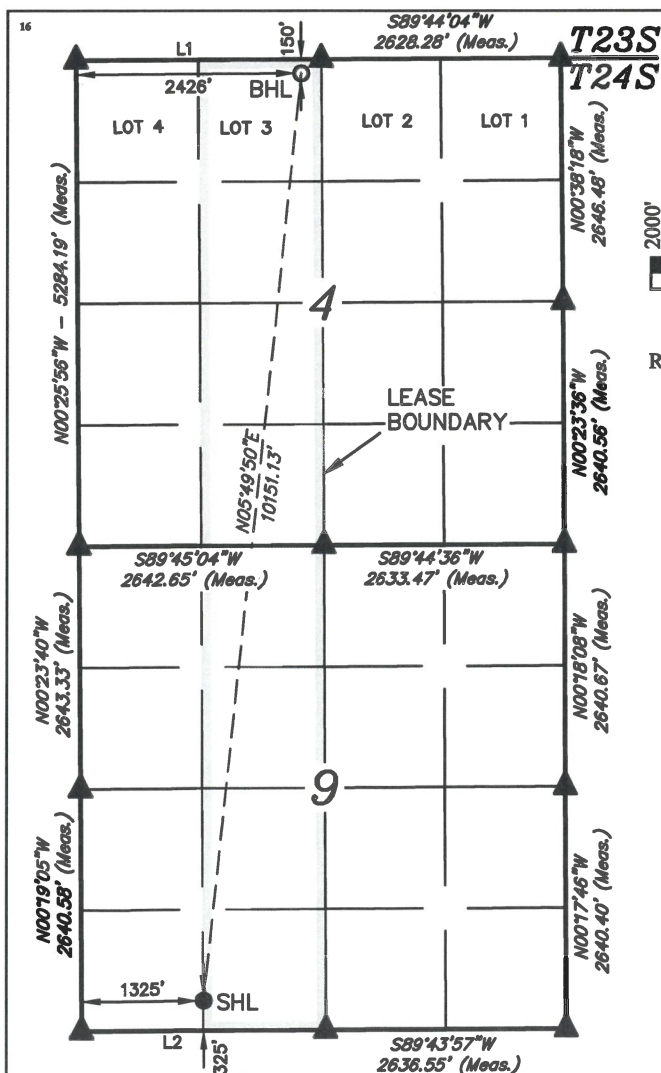

Franklin Mountain Energy, LLC kindly requests the administrative approval of the non-standard location for the Ouray Fed Com 703H well, to be drilled in the WC-025 G-09 S253502D Wildcat; Upper Wolfcamp (Oil) pool (WC-98187). Franklin Mountain Energy plans for this well to have a first take point at approximately 858' FSL and 2,316' FWL of Section 9 and a last take point at least 150' FNL and approximately 2,426' FWL of Section 4, which is closer to the unit line than allowed under the subject field rules. Franklin Mountain Energy, LLC requests this non-standard location because such placement relative to offset planned wellbores optimizes the geometric configuration and subsequent resource recovery under the current development plan.

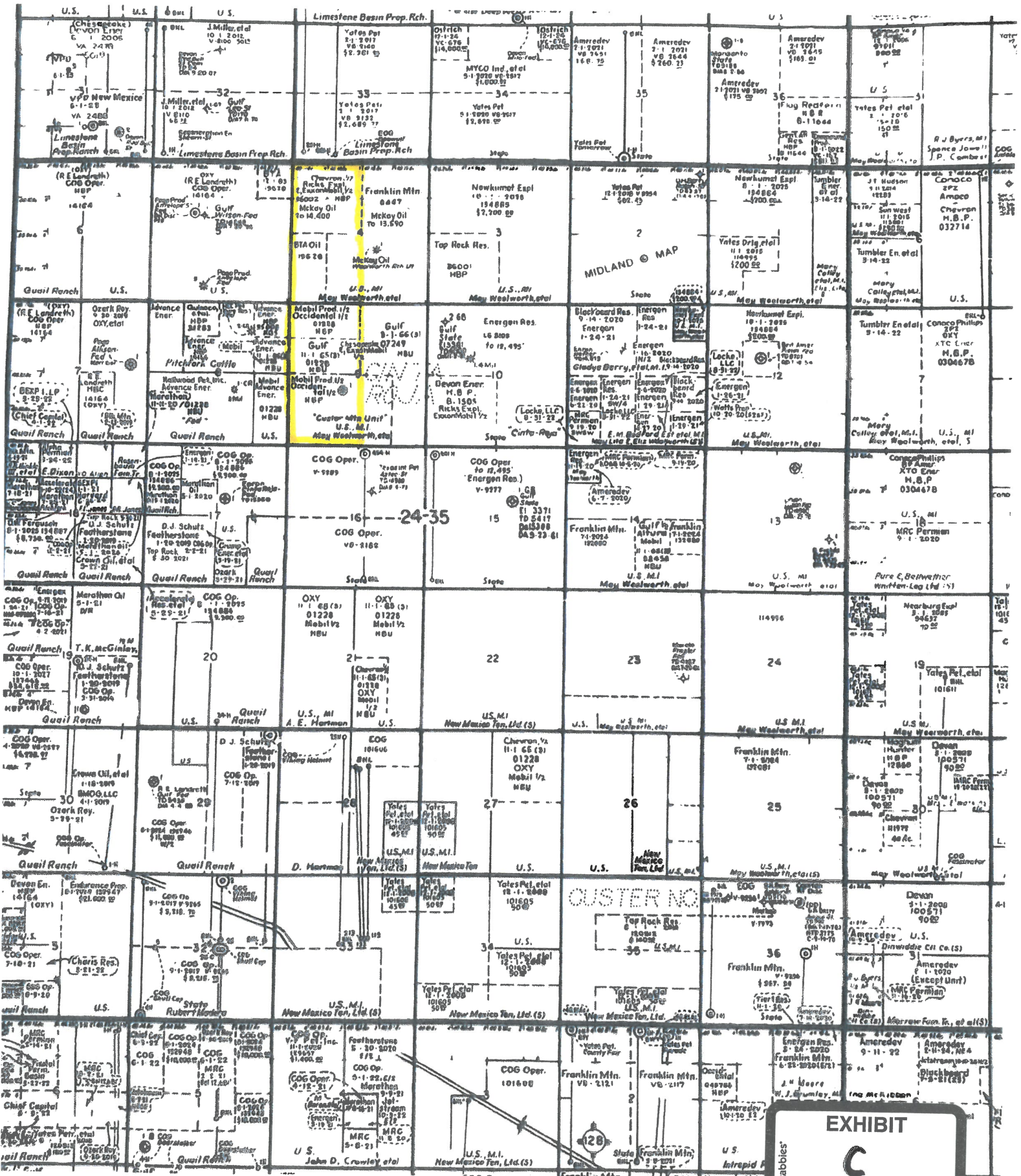

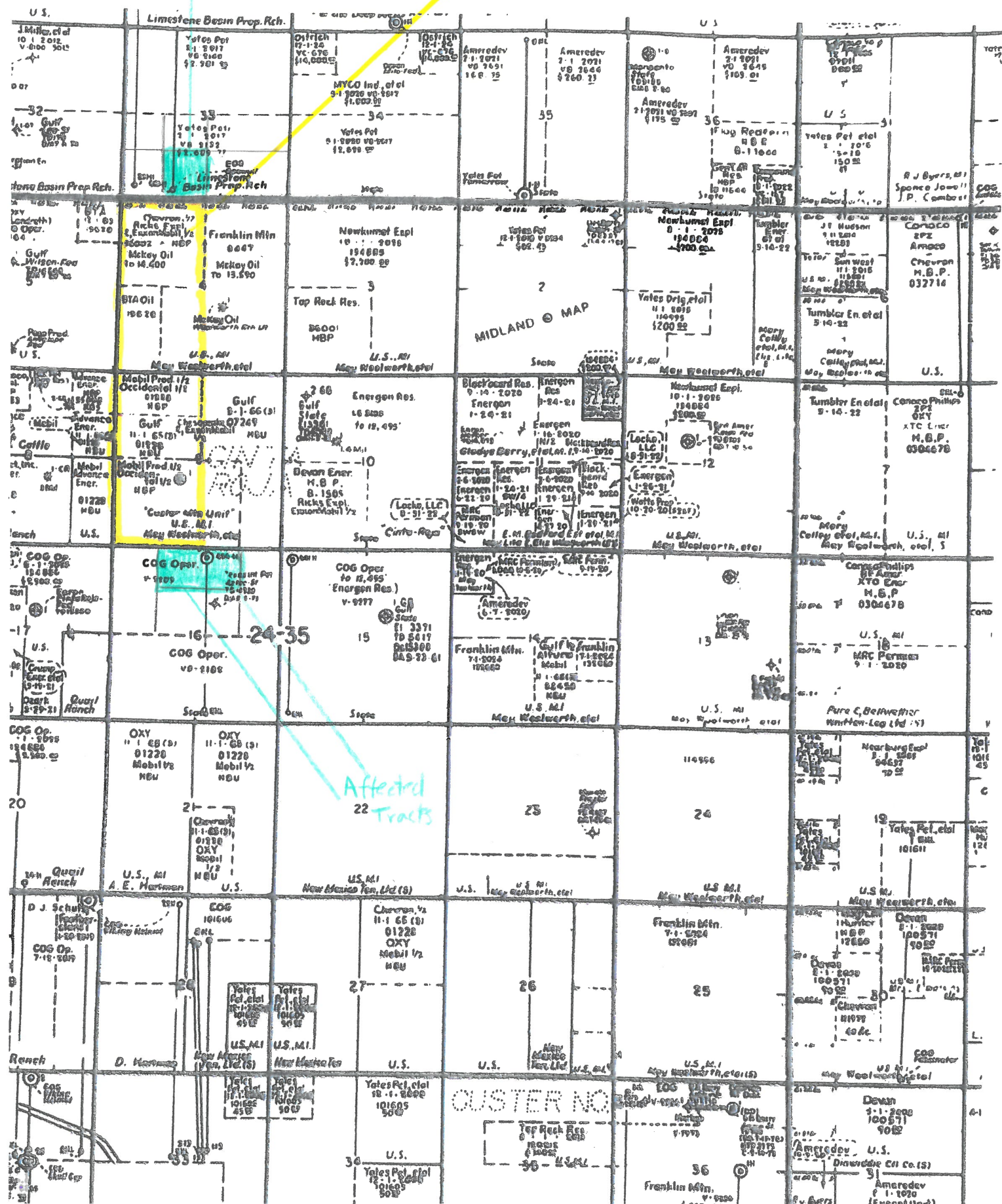

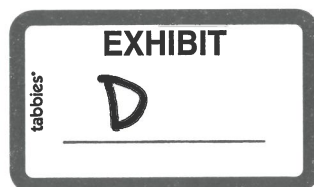
