Mike,

This proposed SWD location is within the DOI Potash Enclave and between two active deep gas wells less than ½ mile away, as well as being located just over ¼-mile north of several horizontal (Ascent Energy, LLC) wells with APDs that will expire in May 2020. I don't see any surface impediments, and the location will likely have no potash mine objections since the mine owners know about the gas wells and APD'd horizontal wells.

The nearest SWD well is over 2-miles away.

How is it going? I hope you are well. I am reaching out to you again in regards to the acceptability of a proposed SWD well location. I am currently reviewing a C-108 application from 3Bear Field Services, who have proposed a well location at:

259' FWL, 3882' FNL in Section 6 Township 21S Range 33E, or 32.51168 -103.619 NAD83

The information available to me indicates that this location is on State Trust lands within the designated R-111P boundary. I wanted to reach out to you to verify that this was going to be an acceptable location for the SLO? Also, if you have any references that might aid me in determining this information on my own, I would be interested in knowing how it is done on your side.
