Please let me know if the information contained in this addendum is sufficient and if you or your staff requires additional information or has any questions, please do not hesitate to call or email me.

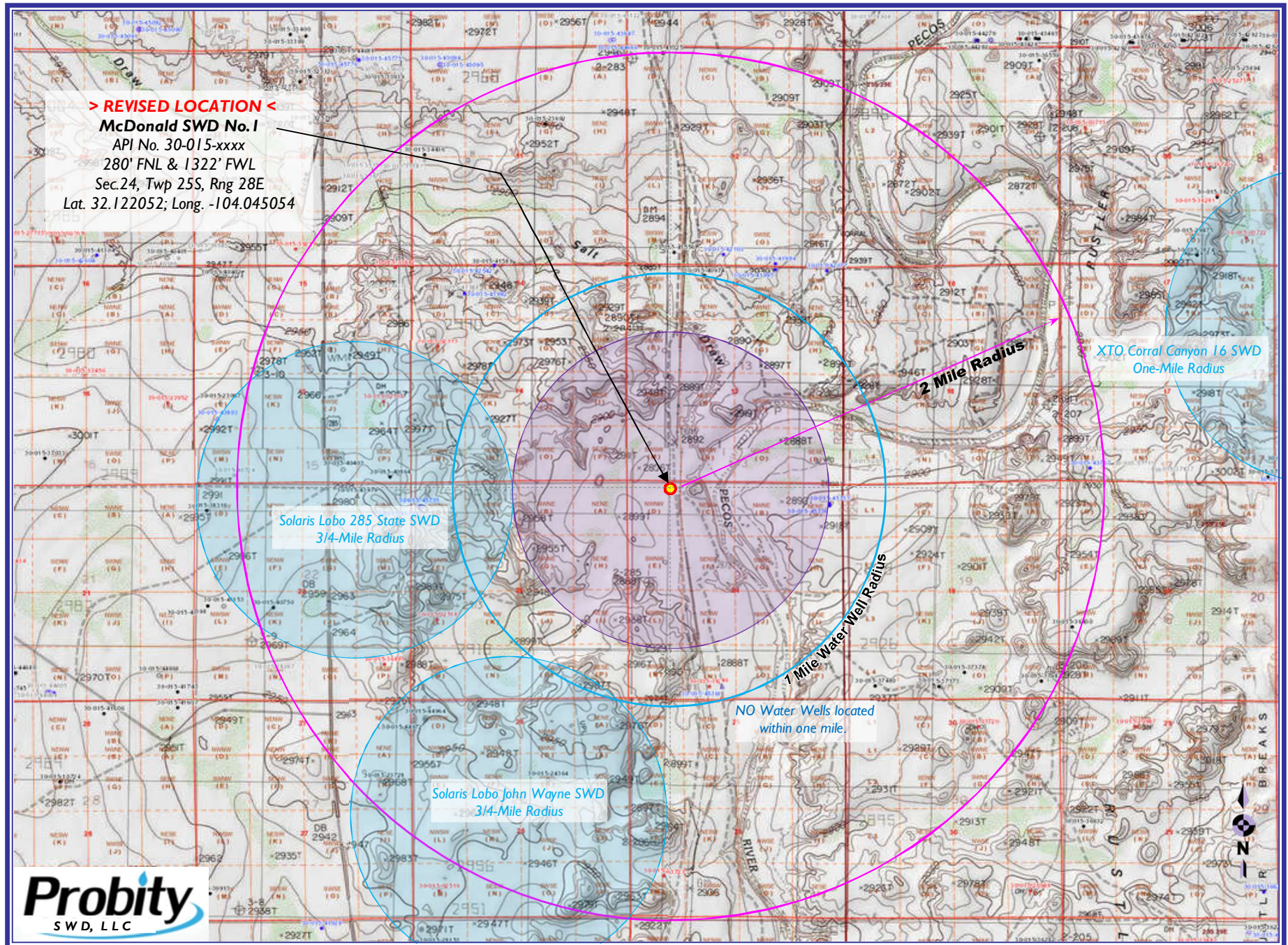

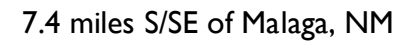

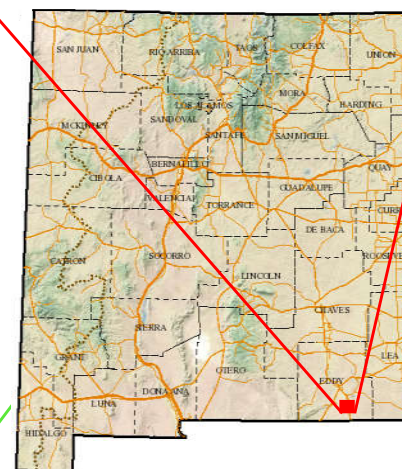

Henry McDonald SWD No.1 (Proposed)

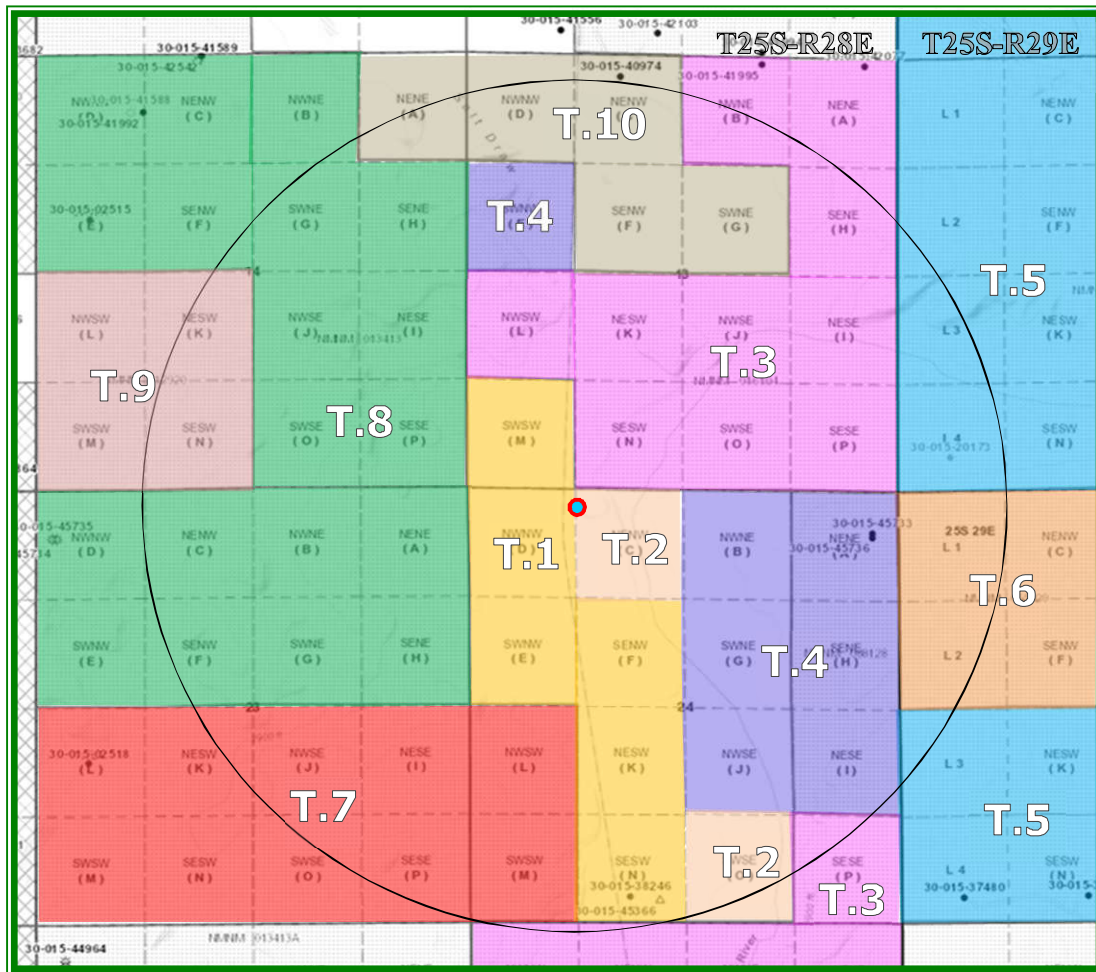

To Whom It May Concern:

Probity SWD, LLC, Midland, Texas, has made application to the New Mexico Oil Conservation Division to drill and complete for salt water disposal the Henry McDonald SWD Well No.1. The proposed commercial operation will be for produced water disposal from area operators.

Due to a competing Devonian targeted SWD being filed a few weeks prior to this project, the well spot has been adjusted approximately $\frac{3}{4}$ mile north of the previous spot. The proposed interval and all other aspects of the project remain the same. The published notice states that the interval will be from 14,750 feet to 15,935 feet into the Devonian (Silurian) and Fusselman formations.

Following is the notice published in the Artesia Daily Press, Artesia, New Mexico on or about April 9, 2019.

Produced water from area production will be commercially disposed into the Devonian (Silurian) and Fusselman formations at a depth of 14,750' to 15,935' at a maximum surface pressure of 2950 psi and a rate limited only by such pressure. The proposed SWD well is located approximately 7.4 miles south/ southeast of Malaga, NM.


